Miracote ColorPax-LIP (Liquid Integral Pigment) is a formulated coloring dispersion that is mixed with the liquid polymer component of cementitious base coats.

WHERE TO USE

Miracote ColorPax-LIP Pack is designed for use in Mirastamp Liquid Polymer and Miracote Liquid Catalyst to produce accent coloration in Overlay Mirastamp, Microtopping DP and MPC Pool Deck topping applications. ColorPax-LIP can be added to Miracote RM White to produce a decorative repair mortar, and can be added to Mirastain II Base to accent applied toppings. ColorPax-LIP is available in all standard colors and can be ordered in custom matched colors.

ColorPax-LIP creates a homogenous coloration dispersed in liquid polymers. Materials incorporating ColorPax-LIP deliver a full depth color that is colorfast, resistant to ultraviolet degradation and is not subject to photo-induced deterioration. Designed for compatibility with liquid polymers, ColorPax-LIP affords development of uncompromised physical properties.

SHELF LIFE AND STORAGE

Shelf life will be one year from the date of manufacture as long as containers remain unopened and when material is stored in a protected environment that is free from moisture, excessive heat and freezing temperatures, and direct sunlight.

OVERVIEW OF INSTALLATION STEPS

(Please refer to the following and contact Miracote with question)

- Mix the ColorPax-LIP with the liquid Component of Polymer Cementitious Systems manufactured by Miracote.
- Pre-shake the bottle containing ColorPax-LIP.
- Pour the ColorPax-LIP into the liquid Polymer.

- Dip the ColorPax-LIP bottle mouth slightly into the Liquid Polymer and partially refill the ColorPax-LIP bottle. Replace the cap and shake the bottle to agitate and mix up any residual ColorPax-LIP. Pour the content into the Liquid Polymer. Repeat as necessary to assure all the contents of the ColorPax-LIP are placed into the liquid Polymer.

Note: This is very important to maintain consistency in color from mix to mix.

- Use a mechanical stirring drill set on slow to medium speed and mixer blade to agitate the Liquid Polymer to yield and evenly colored liquid.
- Avoid working air into the mix. When working on large jobs, ColorPax-LIP can be mixed in Liquid Polymers, however, when doing so, always re-stir the liquid Polymer before blending with dry mix or applying to any surface.

CAUTION

Miracote ColorPax-LIPs are designed for specific uses and applications. Use in any other manner not so prescribed can lead to undesirable results. As the color in ColorPax-LIP is derived from liquid pigment dispersions, the colors are very strong and will set fast to most surfaces. When using ColorPax-LIP, exercise caution not to contaminate surfaces or materials not intended to receive the pigment.

For Best Results:

Install a minimum 4' by 4' test area site mock up for approval of acceptable color, texture, finish, adhesion, and any other critical requirement acceptable to the owner prior to proceeding with the installation.

Verify current versions of product technical data sheets (PTDS), material safety data sheets (MSDS), and installation guidelines (IG) at www.miracote.com.

Protect materials from excessive heat and cold and regularly check wet film thickness with mil gauge and monitor consumption to ensure correct application thicknesses and rate are obtained.
